# HSBC STAFF TURN SUPERHEROES FOR NATIONAL CHILDREN'S HOSPICE WEEK

To mark <u>National Children's Hospice week</u>, which runs from 26<sup>th</sup> April-3<sup>rd</sup> May 2013, <u>HSBC</u> staff dressed as superheroes to entertain the remarkable children at <u>Bluebell Wood</u> Hospice in North Anston, Yorkshire.

In the past three years the fundraising efforts of HSBC staff have helped raise more than £183,000 for Bluebell Wood. The list of fundraising activities organised by staff across the north of England includes black-tie balls, golf tournaments and even a Zumbathon.

HSBC staff have also volunteered almost 2,500 hours of their time to help at the hospice, with activities including decorating, gardening and assisting at the children's Christmas party.

The staff met with nine year old Theo on their visit. Theo was born at 29 weeks and has bravely endured 21 surgical procedures in his short life, and survived both viral and bacterial meningitis. Theo is one of the many young children who have benefited from the support of Bluebell Wood Children's Hospice, which offers care and support to children with a shortened life expectancy, both in their own homes and at the hospice.

"The amount that HSBC have raised for us over the last two and a half years is just incredible," said Julie Hampson, Corporate Fundraiser at Bluebell Wood Children's Hospice. "We have to raise £3million each year to offer our services and we receive no statutory government funding so the money raised will help us to continue to support local children with a shortened life expectancy."

"It is a privilege to work alongside such outstanding charities. HSBC is proud to support the valuable work carried out in the hospices for children with shortened life expectancy," commented Mark Wake, Deputy Regional director, HSBC North Region. "In the current economic climate it is more important than ever that we can improve the lives of many children through funds raised or volunteer hours given; we are delighted to see the positive impact this has on families with a child suffering complex medical needs."

Bluebell Wood is just one of the many children's hospices across northern England which have benefited from the £635,000 raised by HSBC staff since 2010.
